Capability's focussed Overview







Three CVs to add to your walking CV

The estate workers who put Capability Brown's (and estate owner Sir Christopher Sykes') vision into practice, and have maintained it for the past 300 years, also created the village walk on which Capability's Overview, launched ten years ago, is based.

The traditional village walk was held after haymaking to give estate workers the opportunity to see what work had been undertaken since the last harvest and assess the prospects for the coming summer months. The Overview, developed with long distance walkers, covers a larger area and, as the name suggests, presents the landscape canvas Brown worked on.

Sledmere's landscape is unique in many ways. The deep-cut, steep-sided dales of the post-glacial Wolds did not lend themselves to the vast areas of grass parkland developing on the great country estates elsewhere; so a key element of Capability's 1778 plan was the detailing of three double-headed "vistas".

The basic concept was to have three architect-designed farmhouses at focal points on the tree-lined ridges encircling The Big House and its grounds. These were to be The Castle, to the southeast; Life Hill to the south-west; and Maramatte to the north-west.

The aim was to present a memorable panorama whether looking up from the house to the focal points on the ridge or down to the house from the farms.

The Tercentenary Overview gives the intended

three CVs (Capability's Vistas) as well as a close look at the woodlands which are another great feature of the Sledmere estate and illustrate how much greater Christopher Syke's own plans were. After receiving Brown's plan he planted another 177,000 trees on 130 acres of the estate in the 1778-1779 season.

The Overview is organised by Sledmere Parochial Church Council in conjunction with the Parish Church Council; two country estates (Birdsall and Sledmere) and local farmers. The long distance walk (to aid the church, like the village walk on the same day) is largely off-footpath and crosses the Deer Park on its circuit of the Sledmere Estate and adjoining Wolds hills and dales.

The minimum kit required is: map (Explorer 300), compass, waterproofs, first aid kit and mug. All entrants under the age of 18 (minimum age 12 years) must be accompanied by a responsible adult. For conservation, land management and safety reasons, the access to private land on this walk is not allowed at any other time without permission.
