# 21.17 Treasurer's Report:

This report covers the income and expenditure of the Cornwall and Devon group's finances from 1<sup>st</sup> October 2020 to 30<sup>th</sup> September 2021. Please see the attached copy of the income & expenditure report.

Mike Smith has audited & signed off the accounts on 8<sup>th</sup> October. If you want a full copy of the accounts at any time, contact me and I will email you a copy.

There hasn't been much activity during this financial year as you will see from the I&E report. Challenge events; there were two anytime challenge walks put on during 2021.

The Permutational Ecclesiastic Perambulation or PEP walk which was held as a pilot event from January – April.

The Wellington Boot Anytime challenge, which was held from mid-July to the end of September.

We had this year's Chagford Challenge which was held on 26th September. Looking at the income and expenditure report:

Wellington Boot Anytime Challenge: There was a small entry charge for this event to generate some income for the group.

Chagford Challenge: Due to the dates of the C&D financial year, all of the income (entry fees) is shown in this year's financial report. All of the expenditure will be shown in next year's report (2021/22).

Devonshire Dumpling: This event has been mentioned even though it doesn't take place until April 2022, as a deposit has been paid for the hire of the Budleigh Salterton Town Hall.

Westcountry Storage: This is the cost of hiring a storage unit, where the equipment for our challenge events are stored, something we need but one of our biggest expenses. There have been 13 months paid as the original invoice for September 2020 went missing, this was only noticed when I did an audit on the accounts. Miscellaneous: There are no items in this category.

Tor Bagging: This for a number of certificates bought during the financial year. Social Events: The event planed for this year was rescheduled 2022, due to the uncertainty of Covid restrictions. Clothing: A tee shirt was sold & a number of tee shirts etc were bought, as stock was getting low.

Interest: This was paid on our funds in the deposit account.

As you would have seen from the Income & Expenditure report the Cornwall & Devon Group, have £8293.69 in our two bank accounts. But most of the expenses for the 2021 Chagford Challenge have yet to be paid.
