#### 1. Chairman's welcome

HG welcomed everyone and said that the main aim of the meeting should be to decide whether the group can run The Dorset Doddle this year. She acknowledged that the new committee members lack experience with regard to organising a challenge event but also that this is unlikely to change if we leave it another year.

It had been agreed, before the meeting, that discussion of the Dorset Doddle would take place at the beginning, to allow those non-committee members attending to leave the meeting after this item.

There followed considerable discussion about running a challenge event such as The Dorset Doddle. It was generally agreed that the newer committee members needed training and support from others in the group (both current and ex committee members) who have experience in the various aspects of running challenge events. In this way it is hoped that a new set of members will be able to develop their skills.

MC identified a number of key areas for which a lead person will be needed in the planning process. These were:

- Catering
- Checkpoints
- Route description and checking
- Recruiting and communicating with volunteers (marshals)
- Transport
- IT

He said there are also a number of roles which would need to be covered on the day of the event.

A decision was taken to go ahead with the event, which will be run by a sub-committee, made up of both committee and non-committee members. HG volunteered to chair the sub-committee.

There was some further discussion regarding the various roles and some members present agreed to lead in different areas.

The date of the marshals' event, on which AB agreed to be the lead, was confirmed as 24 Jul 2022.

The first online sub-committee meeting was arranged for 4 Apr 2022 at 7.00pm. CP agreed to set this up on Teams and send a link to the other sub-committee members via email.

### 4. Matters arising from the online meeting 31 Jan 2022

#### 5. Approval of the minutes of the meeting 31 Jan 2022

#### 6. Treasurer's report

The Group Treasurer (IB) was not present at the meeting and had not sent a report to the committee prior to the meeting.

### 7. Social walks programme

TL gave a short review of the walks program since the last meeting in January. It contained the following information:

The walks program had been very buoyant, with varied, interesting and enjoyable walks. These had been well attended, with about 20 people on each walk, and positive feedback had been received on each one.

There has not, as yet, been any "first time" leaders, but some new members have indicated an interest and it is planned to possibly run a joint walk with them later in the year.

TL continued that she has not sent out a bulk email, as mentioned in the last committee meeting, because she is finding that presently individual approaches are working best. She said several members have promised to lead walks and she will be pursuing them for details. There are a couple of spaces for April and May 2022, which may be filled by last minute offers and she will send an email to update members if this occurs.

HG asked which dates were still available in May and TL said the 1<sup>st</sup>, 8<sup>th</sup> and 22<sup>nd</sup> were not yet filled.

### 8. The EBB 100 2023 - the possible Dorset Group checkpoint

HG agreed to resend to the committee, a document she had received from the EBB 100 co-ordinator regarding the possibility of the Dorset Group running a checkpoint at this event. It was agreed that this should be on the agenda for discussion at the next committee meeting.

There was a short discussion of the checkpoint the Dorset Group had been offered, in which CP stated that a checkpoint 22 miles into the route would be difficult to run and demand a large number of volunteers. It was agreed that we are not in a position to run such a checkpoint and HG said she would let the co-ordinator know and await his response.
