### SECRETARY'S REPORT

The publication of our monthly newsletter has been maintained throughout the year, with circulation continuing to increase steadily each month. The upward trend is mainly due to the number of associate members we have, i.e. those members from other groups who choose to receive our e-mails from us. #### TREASURER'S REPORT

The Wiltshire LDWA's balance at Barclays Bank was £7,849 at the 9<sup>th</sup> November, an appreciable increase on last year's figure of £5,990.

The principal items of financial activity for the group were the same as in previous years, i.e. the AGM meal subsidy and the Pewsey Downsaround (PDA). The meal subsidy for last year was £721, and is expected to be about the same this year, despite the subsidised proportion being higher.

The PDA made a surplus of £2,862 in 2023, largely due to an increase in charges from a similar number of entrants as in 2022. Due to the significance of this item in the balance sheet, a more extended breakdown of the income and expenditure compared with prior years is detailed below. A full list of payments and receipts is available on request.

The other item of note was the Elephant, Bear and Bull (EBB) 100 support team, which spent about £500 in travel, food and t-shirts. Coincidentally (?), we received £500 as our share of the surplus from the EBB organisers.

This will be my last report as treasurer, as I am standing down at this AGM.
